Members were provided the **MSPF2 Contributing Factors Summary**.

In small groups, members reviewed the summary together and discussed the new findings from the recent data.

Each member was provided 3 sticky notes. Each contributing factor was posted on the wall in the room.

Members were asked to pick the 3 contributing factors that they thought was most important regarding the data findings.

The coalition, in a whole group discussion, then prioritized the contributing factors based on the number of sticky notes they received, high or low impact, and high or low changeability.
