12:15–12:35 pm: Overview of the MSPF 5 Step Process Model – Caitlin Hall, Prevention Specialist

Caitlin Hall facilitated a quick overview of the 5 Step Maryland Strategic Prevention Framework (MSPF) Model. Needs Assessment (collecting data – quantitative and qualitative). Capacity building is on going and it's building and increases members involved with the coalition and in the community. Strategic Planning. Implementation (Actual "doing" of the community strategies). Evaluation is when our progress is evaluated, and goals are measured.

Caitlin further explained Intervening Variables and their definitions. Contributing Factors are Retail Availability, Social Access, Enforcement, Pricing, Promotion, and Individual Factors.

Retail Access - Availability of alcohol in your community/how easy is it to obtain alcohol

Social Access - Obtaining alcohol from friends, associates, and family members

Enforcement - The impact of law enforcement practices and judicial processes on underage drinking, binge drinking, and alcohol-related crashes

Pricing - The cost of alcohol and the extent to which changes (i.e., discounting or price increase) affect consumption

Promotion - Attempts by alcohol retailers and industry to increase demand through the marketing of their products
