**2. Compliance Check Data Presentation** – Jake Lewis, DOH Intern

- a. 4 substance abuse coalitions do restaurant/bar checks
- b. 2012 to present: 532 checks at 142 establishments
- c. Passing rates: 84% 449
- d. Failed Citation 83 (9%)
- e. Failed Non Citations 37 (4%)
- f. 96 zero, 31 six or more times
- g. Total: 142/238 (60%) completed checks listed in jurisdiction; percentage of overall compliance checks by jurisdiction - ASAP 28/66 (42%), 28/142 (20%)
- h. Locations with lowest pass rates, many fall within ASAP's jurisdiction (4/12)
- i. 2012: 11/11, 2015: 33/41(80%), 2016: 80/88(91%), 2017: 98/112(88%), 2018: 225/280(80%)
- j. Vacant positions were liquor inspectors, have been rolled into unit in PD
- k. Health Dept helping to fund compliance checks for city of Annapolis
- l. Pass Rates: A-Liquor Stores, 276/322 (86%);
- m. 36 locations in Annapolis/AA County as yet unvisited; 124 total unlikely to receive underage activity
- n. Data received for AA County Police/APD/Liquor Board
- o. 13 locations visited once
- p. Questions:
  - i. why are locations continuously visited after passing majority of checks?
  - ii. Why are so many (95) not visited at all? – some places picked at random/after a complaint;

- iii. nearly half of failed locations (37/83) not issued citation, result of missing info?;
- iv. Some locations visited 2x week, Why? Depends on what kind of check being performed (not always for underage drinking), or complaint follows recent compliance check;
- v. Why are there two different classes (B and H) for same thing? Some classes for different grades of alcohol service;
- vi. Class B establishments (restaurants w alcohol) had lowest passing rate
- q. No Annapolis city establishments were visited 2x in one week

### 3. Drug Free Communities Grant & Coalition Involvement Agreement Breakdown – Angel

Traynor, ASAP Coordinator & Jessica Correll, ASAP Co-Coordinator

- a. Coalition had opportunity to apply for DFC Grant: Coalition Involvement Agreements in order to apply for DFC, one rep from 12 different sectors required (no more than 12)
- b. 2 5-year terms renewable, 5 million available with the grant
- c. Request for Proposal for 2019 not yet released; starting with 2018 info
- d. Health Dept afforded funds for grant writer for our DFC
- e. MSPF ends June of 2019, FY 19 ends June; new FY in July, MSPF-2 good til '20
- f. Will be un-funded for short period of time between grants but we will be ok
- g. Help needed from Coalition Members for CIAs
- h. Each sector will have specific responsibilities, they cannot be a paid member of faith-based or paid community-involvement worker
- i. Come April we will need the CIA commitments, hand-signed and dated, no e-signatures, unique signature for each commitment
- j. Recommendations for Representatives/Agencies
  - i. Must be a member of the ASAP Coalition (definition of member needed)
  - ii. For youth rep: must be representative community leader, role model, supportive of mission of coalition, attending coalition meetings and community events, contributing to strategic action process, preventing youth substance abuse through environmental strategies
  - iii. Can Business and Law Enforcement/Gov Agency sign, conflict of interest?
  - iv. State/Local Gov: concentration is Annapolis City, is there a preferred representative, i.e. Adetola
  - v. Can more than one person sign for different sectors
