 - 2. CCRABL Data Presentation Corinne McCray, Intern, DOH
 - a. ASAP has been tasked with providing data for APD, to analyze the report, key interviews with officers, and members of liquor board
 - b. Report made up of city council members purpose of reviewing beverage license laws and recommendations. Est 2010 Jan 25, Final report released July 15 2010
 - c. Report Summary:
 - i. Annapolis establishes own license fees; fees must be reasonable and have definite relation to purpose and none more than necessary. FY10 determined that cost of City services for licensing was 54% higher than fees collected in 2009. Committee is convinced that increase was warranted and recommended that licensees be credited any amount overpaid until City demonstrates that the increase is reasonable
 - ii. Liquor Licensing: Ability to enforce laws/regulations pertaining to liquor licensing based on interdependent chain of responsibilities made up of City gov., ABCB, APD, license holders, and residents of Annapolis. Revise fee schedule dependent on square footage.
 - 1. <u>City Government</u>: Committee identified conflict between licensees and residents stems from subset of unruly patrons, and that licensees are improperly targeted for these issues, and suggests that City implement policies to help.

- a. One part-time contractual inspector employed through APD. Committee recommends at least one FULL TIME inspector, to act as liaison between City, APD, ABCB, residents, and businesses.
- b. City should create public parking. City should create more access to public restrooms. City should relocate taxi stand, currently on Main St., which is frequent site of disorderly conduct. Committee recommends campaign for no-tolerance-policy against disorderly behavior. Committee also recommends more formal relationship and reporting between Dept. of Planning and Zoning and the ABCB to minimize non-compliance with zoning restrictions.
- 2. <u>ABCB</u>: tasked with creating rules for retail sale of alcohol, board members are five volunteers each serving 3-yr terms. Staff support provided by City Clerk office. Committee found that workload is overwhelming, and important data information is not readily available as result.
 - a. Committee found that Public Hearings held first Wednesday of month at 3PM – are held at an inconvenient time for general public and licensees, and recommends new time.
 - b. Committee recommends that ABCB provide written documentation for approving or denying new license application, which should also explain public need for approval.
 - c. ABCB should reduce number of years on licensee record of penalties imposed, from 4 years to 3.
 - d. Committee recommends raising penalty fees for sale of alcohol to minors, and also recommends escalating scale for repeat offenders.
 - e. ABCB should establish fines for public intoxication or use of fake IDs, and post requisite signage.
 - f. Committee recommends that Article, stating at least one license holder be Annapolis resident, be changed to allow holder to be Anne Arundel County resident. Also recommends making ABCB website more interactive.
 - g. Require info mailing to residents within 200 ft of new license application, paid by applicant.
- 3. APD: conducts compliance checks.
 - a. Committee suggests more collaboration between ABCB and APD to ensure proper enforcement, and protocols developed to assist collaboration between them and licensed establishments.
 - b. Recommends APD increase staffing (i.e. patrol and booking offices) on weekends, nights, and during events.
- <u>License Holders</u>: can assist in prevention of sale to minors and public intoxication by requiring staff to be certified in TIPS or other alcohol awareness classes.
 - a. Should post signage where appropriate to demonstrate penalties for unlawful behavior
 - Relationship between Licensees and APD should remain mutually beneficial and recommends establishments not be disciplined solely on number of calls made to APD.

- 5. <u>Residents</u>: Committee identified neighborhood watch programs and attendance of ABCB meetings as necessary to address problems.
- iii. **2AM Closing Time**: Committee recommends designation of license category to be clarified for proper issuance of license. Currently, restaurants serving alcohol, with 2AM closing times, have no restrictions on food to alcohol sales ratio. There are currently NO establishments licensed as bar/tavern in the City. Recommends amending Title 21 and Title 7, to distinguish types of license ("restaurant" title too general for Annapolis).
 - 1. Recommends the following classifications:
 - a. A restaurant open until 12AM should be subject to 50/50 ratio of alcohol to food but NOT required to obtain special exception approval. Restaurants with current 12AM license in C-2 zone should be permitted to apply for 2AM license within 6month period, without special exception, and after approval subjected to 60/40 ratio
 - A restaurant open until 2AM should be subject to 60/40 ratio and permitted ONLY by special exception with limited menu available during certain hours
 - c. A bar/tavern would be open until 2AM with no alcohol/food restrictions, but would be permitted ONLY by special exception, and subject to higher fees/penalties. Would require amendment to Article 2B.
 - d. Committee recommends food-to-alcohol ratio be requirement of Title 7 and enforced by ABCB.
 - 2. Restricted Areas for Liquor Licenses: City has experienced dramatic growth; Committee recommends use of temporary "restricted area" classification for new liquor licenses, with potential areas designated by City's 6 commercial districts. Committee recommends Board of License Commissioners have ability to temporarily restrict issuance of new licenses within specific districts in order to control appropriate mix of uses.
 - a. Board would hold hearings for testimony for or against possible restrictions. Approved restrictions would be in place for period of 1-4 years and end at fixed period unless hearing is held and further restrictions implemented.

d. Notes:

- i. Public urination issue: HarborMaster is always open
- ii. Change in city code? Criminal violation for servers to serve underage guests.
 Liquor board reviews establishment infraction, server goes to District court separately;
- iii. Report suggests license fees would cover cost of full-time liquor board inspector; had two part-time, went to one, the one quit, position no longer budgeted;
- iv. officers at night: usually are more on staff and present during nights and weekends and in the summer
- v. Officers are allowed into the bars/restaurants before problem arise but typically don't at night for personal safety reasons
