 - ii. Incorporate alcohol laws into mandatory in-service trainings

- e. Business checks police might be able to walk into establishments and card people who "look underage" or whether the establishment is over capacity
- f. No precise nature of data recording planned yet
- g. No exact "checklist" for officers to use during business checks, yet
- h. What will Policy do? Support community conscience, a shift in perception at the community level; reduce under-age drinking, excessive/binge drinking, and alcohol related fatalities
