 - a. **Changes of Staff**
 - i. *Leslie Beers taken on role as Coordinator*
 - ii. *Resignation of Chair, Secretary, & Treasurer; **will need to hold elections in March 2022**. Must be volunteers from community, focus on membership recruitment & coalition awareness*

3. **Strategies**
 - a. **Capacity-Building-** *update on event with speaker Ray Lazano- soft hold date is 3/11, letting Ray decide where he will fit best (SOS or SADD Conference, or something else?); depending on that decision, we are still wanting to use him for Coalition Meeting Event to recruit members*
 - i. *At the start of 2022, we will be doing some door-knocking and cold-calling to recruit membership and raise coalition awareness*
 - ii. *Police Community Relations Council (PCRC) meets monthly (every 3rd Thursday evening). We plan to collaborate and get on the agenda for an upcoming meeting (February?) to raise awareness and gain capacity*
 - b. **Responsible Beverage Service -** *upcoming TIPS training*
 - i. *Leslie has completed the TIPS Train-the-Trainer course and is now certified to facilitate trainings*

- ii. *Upcoming TIPS training in late January for restaurant employees of various locations. Leslie will create a TIPS flyer specifically for SCB Coalition to help promote TIPS in general for this region.*
 - c. **Narcan Training-** incentive? Ideas to build attendance/new ways to market- *Looking into ways to market/advertise. Problem in the past is we get registrations online, but then no-shows. Daytime class seems a better option than evening. We can put advertisements in public places like libraries, grocery stores, anywhere that allows public postings.*
 - d. **Vaping/Marijuana Toolkit-** we have the resources to put together; distribution- *Get in touch with PTA and/or SADD Chapters as an outlet for distribution; could distribute at Ray Lazano event or even SOS in southern district schools if possible; Target audience for Prevention Toolkits is middle school students & parents.*
