- 2. OMPP Update-** Justin Noel - *distributing provider rack cards*
- 3. Capacity Building** -Angel Traynor - *We want to campaign aggressively to get our attendance back as it was pre-COVID, an average of 20-30 members in attendance at each monthly meeting. To do this we ask that you share meeting invites with your contacts; we are working to run an article in the paper to help raise awareness; share blogs and other Facebook posts because it does make a difference in reaching more people.*

- a. *Idea to have June meeting at a different location, downtown maybe, and personally invite community leaders, city council, mayor's office, etc, to hopefully gain capacity and raise awareness. Lunch from Bread & Butter?*
- b. *High School Senior/Junior internship, for the fall, to help capacity and get more youth involvement*

4. Updates from APD- Nicole Vaden - *APD has been very busy with community outreach events. OEM- the Overdose Dashboard shows fatal overdose numbers are higher than nonfatal overdose numbers.*

- a. *(Judy) McDonnell Hall is being remodeled and Pip Moyer is going to house the boxing equipment which will turn into a mentorship program for community youth (boxing); open by fall/back-to-school*

5. Strategies

a. Safe County Alliance (formerly Restaurant Partnership)

- i. *Ordered promotional items for Welcome Bag–coasters, table toppers & menu inserts with QR codes, backpacks, pens, server notebook, mints, hand sanitizer, employee poster– all with logo - working to create brand recognition and get restaurant buy-in*

b. TIPS Training-

- i. *In the past month (30days), we have done **4 training sessions**, 1 Off Premise (packaged goods), 3 On Premise (bar/restaurant); trained **76 participants** at **16 establishments**.*
- ii. ***Alcohol Retailer Folders-** recent alcohol compliance check fails will be first getting the retailer folder to offer free TIPS - will be distributed by the end of June/before June coalition meeting; will include information about Safe County Alliance*

1. *Letters have gone out in the county and greater Annapolis area to give heads up that compliance checks are coming.*

c. **Narcan Training-** in the past month, we have distributed approx. 40 Narcan kits via recent TIPS training sessions
