2. Opioid Misuse Prevention Program Update
  - Train the trainer for SADD programs at various schools is continuing to be done
  - Prescriber outreach is being worked on so that prescriptions can be called attention to and information about substance misuse.
  - Efforts are being made to put opioid misuse information on the label
  - Training for pharmacists to start with low dosages and try not to give opioids or a massive number of medications.
