2. **SADD/OMPP Update - Justin Noel (OMPP position open for application)**
Justin has been working with schools to get SADD chapters started and/or revived; he has 8 schools currently interested in moving forward and next week will be visiting several more to gain interest. The SADD Conference is set to happen around January 5th 2023 (date could change).
3. **Strategies**
 - a. **Capacity Building-** *Look for where we can post Coalition Information Flyers like libraries & churches. Discussed holding an evening meeting event, possibly quarterly depending on outcome, looking at November (11/4). Possible ideas include:*
 - i. *Host it at the Deale Elks. Ask local restaurants to 'Donate a Dish' to provide the food; this would give us a chance to partner with and promote restaurants and segue into Safe County Alliance.*
 - ii. *We would need to find a Guest Speaker (suggestions?).*
 - iii. *Have volunteer opportunities with sign up sheets available. Make note of/bring up elections for Secretary, Chair (& Treasurer?)*
 - iv. *Pick a strategy to highlight??*

- b. **Safe County Alliance-** *Mayo Liquors expressed interest during compliance award distribution. Follow up with establishments to get surveys completed; visit any other restaurants to get more surveys done*
- c. **TIPS-** *officially in the FY2023 budget; Linda is checking with Deale Elks to host a training on 10/10 or 10/17*
 - i. *Find ways to promote TIPS–Yellowfin, The Edgewater Restaurant, Glory Days, Pirate’s Cove*
- d. **Narcarn Training**
 - i. **AACPL Collaboration** *Leslie has spoken with the Library’s Outreach Coordinator about hosting monthly public trainings at the various library branches; every 2nd, 3rd, etc Saturday of the month. Plans are not yet confirmed, but we are working on it.*

4. Southern Police District - PCRC Update

- a. *DARE Camp was very successful with 22 youth in attendance, plans in place for next year and to maybe do for more days.*
- b. *Themed movie nights starting monthly; 9/23 showing Monsters University*
