2. Capacity Building - *Going into the fourth year we will apply, we have brought plenty of consultation in to help us spend the next nine months or so getting prepared to have what the DFC wants to see on our application. Big focus will be on gaining capacity in the 12 Sectors of the Community as listed below. We have signed "Coalition Involvement Agreements" from this past year's application, some need to be refreshed, and we would like to have 3-5 Representatives from each sector to make sure we are more than covered and are seeing attendance and regular participation from each sector. Highlighted are the sectors we need the most coverage on- (*NOTE* each Rep can only Rep for ONE sector)*

- **DFC 12 Sectors of the Community- Youth (persons \leq 18 years of age)**
 - **Parents** • **Business community** • **Media (have 1)** • **Schools** • **Youth-serving organizations (have 1)** • **Law enforcement agencies** • **Religious or fraternal organizations (have 1)** • **Civic and volunteer groups (have 1)** • **Healthcare professionals** • **State, local, or tribal governmental agencies with expertise in the field of substance use** • **Other organizations** involved in reducing substance use
- *It was suggested to use SADD groups to incorporate Youth into our monthly meetings, or during our monthly meetings, share an Update from SADD Chapter (Kerry Mueller says Annapolis High has a chapter and can help us make the connection with the teacher involved to discuss further).*

3. Strategies

- a. Safe County Alliance-** *Leadership team is going revise the plan to focus on marketing the brand before attempting to get buy-in from establishments since it has been proving to be a challenge; people in*

general are not understanding the real purpose of this initiative or how it can benefit the establishments and the community

- b. TIPS Training-** *Since last month, a decision was made to have all participants register prior to training to encourage accountability and so the trainer has a clear idea of how many to expect.*
 - i. Follow up with Annapolis Mall Management & Annapolis Towne Center about hosting both TIPS & Narcan training with staff*
 - c. Narcan Training-** *Leslie has partnered with the Anne Arundel County Public Library to host Narcan Training open to the public at several upcoming dates; various branches have shown a lot of interest in hosting, but getting the word out there and promoting needs more work (the events are listed on AACPL.net Upcoming Events, the individual branch's website and social media, plus Prevention website and Facebook).*
 - d. Needs Assessment-** *all year to complete. (MYSA Survey running for another 2 (?) weeks—see website for details to promote/share)*
 - i. Listening Sessions-** *Volunteer opportunities for Facilitator, Greeter, Recorder, and Moderator; Leslie has a few groups ready to book in the near future. Contact asap@prevents substancemisuse.org if interested.*
 - ii. Surveys** *will go out to AACPS students. Other surveys can go to Private Schools or Homeschooling groups. Not youth groups or sports groups because they are most likely doing it through the school system,*
