- After an unsuccessful submission last year, ASAP is preparing to submit again in 2023 (for FY2024). Kayla Spiegel, previous ASAP Coordinator, has been hired again as a consultant for her experience in grant writing and the DFC. We have representatives for most of the 12 community sectors. Marte mentioned that a colleague at Luminis could serve for the "Other" sector if needed. Most contracts will need to be updated. We do want to find multiple representatives for each sector.
- For the Youth Sector, we discussed having the SADD Chapter at Annapolis HS provide updates on their activities to the Coalition through Kerry Mueller, their SADD Advisor. In turn, ASAP will send them updates to discuss at their SADD meetings. By doing this, we can learn how SADD & ASAP can help each other/collaborate.
  - Current SADD Update: Students wrote to their principal about how they can cut down vaping in the school. ((DARE has a program about vaping: Nicole Vaden will send to Kerry for SADD.))
