WASP MONTHLY MEETING August 12, 2024

Attendees (all virtual) - Katie Wargo, Denise Williams, Desi Thomas (Suicide Prevention), Justin Noel (SADD), Sgt. Christina Shepard, John Bullis, Philip Rismiller (all National Guard)

There were some technical issues at this meeting since it was all virtual. Some attendees were not granted entry access.

After updates, Katie opened the meeting with discussions and suggestions for new members from our 12 sectors. While we have many sectors covered, we need help filling the other. Our biggest obstacle is having a "WHY" someone would like to be a member since most initiatives don't allow outside community members and would like to have more Lunch and Learns set up for meetings. Desi Thomas offered Suicide Prevention, New Presentation for Schools, and Justin Noel offered Youth Prevention/ SADD: Updated "OKAY 2 Talk." We asked, "If you could change one thing we do, what would it be?"

- We're going back to one coalition, maybe two.
 We need volunteers and community participation. There is too much overlap at meetings.
- 2. We need to do "new" Boots on the ground. We need to attend various community events, truly get out into the actual community events, and hear the inner community's concerns. ——— Look into finding these to shape the coalition for the better and bring trust to the coalition.
- 3. I'm going back to one coalition. You seem to be spread too thin, and we need to be back as one and work together.

We also discussed Gaining new partnerships for the coalition to expand:

We asked for members to expand on suggestions on local facilities, establishments, or people to contact, and they said the local rotary clubs and local churches. I asked Justin for his church contacts and information on the local health ambassadors.
